### 1. Programme Structure

The programme includes an appropriate element of training in research skills, and the structure is flexible enough to allow students to follow their personal interests within the field, including creative writing. This year, all students studied through the medium of Welsh, but English-medium work is also possible. It is good to see an element of work experience at this level.

### 2. Academic Standards

The programme's standards are in line with what is expected from a Masters degree and compare favourably with similar courses in other institutions. Two of the three students succeeded in achieving the standard of distinction, without question.

### 3. The Assessment Process

The scheme is assessed through course work only, as is appropriate at this level, but the nature of the tasks set varies, including a critical survey, original analysis, creative work, self-assessment, oral presentation and detailed reflection on work experience. All pieces were marked according to detailed and suitable criteria and the assessment process was completed in line with the University's procedures.
