1. Programme Structure

The programme is a 40 credit course that provides the professional qualification required to enable pharmacists to apply for annotation of the GPhC register as an Independent Prescriber. The programme is reaccredited every three years by the GPhC. The portfolio that students are required to keep shows their development throughout the duration of the programme and contains a variety of assessments that ensure their competence.

The programme has two intakes a year. This report refers to the second intake in the academic year 2015-16 who completed at the exam board held on 3rd November 2016.

2. Academic Standards

I reviewed a selection of student work from the cohort. The academic standards of this programme are consistent with those in my own institution. All those successfully completing the programme had well exceeded the level to pass.

3. The Assessment Process

The programme employs a variety of assessment methods including a therapeutic framework, a reflective narrative, the portfolio and an OSCE that is

assessed by the DMP. Together these assessments ensure that the student has achieved all of the learning outcomes and can demonstrate the competencies in the prescribers' competency framework.

A number of new tutors had been employed to assess this cohort of students. There were robust systems in place in order to train and quality assure these new tutors.

SAMPLING OF TAUGHT MASTER'S DISSERTATIONS BY EXTERNAL EXAMINERS

External Examiners shall be expected to see prescribed numbers and ranges of Dissertations, but not to mark them, on the following basis:

At least 10% of Dissertations for a postgraduate taught Master's Programme, or a minimum of 10 (whichever is the higher figure) must be seen by the External Examiner(s). Where the total number is less than 10, all Dissertations must be seen by the External Examiner(s) #.

Dissertations seen by External Examiners should include examples from across the whole range of achievement (i.e. Pass with Distinction, Pass, Fail).

External Examiners will retain the right to see other Dissertations at random.

Where more than one External Examiner is appointed on a Programme, at least 10% of Dissertations, or a minimum of 10 (whichever is the higher figure), should be seen collectively by the External Examiners.
