

ANNEX TO SENATE REGULATION FOR AWARDS OF CARDIFF UNIVERSITY

Statement of the University's General Entrance Requirement

The University seeks to provide fair and equal access to all who have the potential to benefit from the University's research-led learning and teaching environment.

- 1.1** Applicants for entry to taught Programmes or to programmes of research must:
 - 1.1.1** satisfy any applicable University language competency requirements, as detailed in the University English Language Policy and/or the University Welsh Language Policy.
 - 1.1.2** satisfy any additional entry requirements specified for the particular taught Programme or programme of research.
- 1.2** Applicants for entry to postgraduate taught Programmes or programmes of research must, in addition to meeting the minimum requirements set out in paragraph 1.1 above:
 - 1.2.1** hold a UK higher education qualification at CQFW credit level 6 or above from a UK institution with relevant degree awarding powers as recognised by the UK government and detailed on its website at:
<https://www.gov.uk/recognised-uk-degrees> ; **or**
 - 1.2.2** hold a non-UK qualification equivalent to CQFW credit level 6 or above¹; **or**
 - 1.2.3** for postgraduate taught Programmes only:
 - i be able to demonstrate to the satisfaction of the Head of School or nominee that they have held, for a minimum period of two years, a position of responsibility relevant to the Programme which they intend to pursue; **or**
 - ii in exceptional circumstances, to be deemed to be able to demonstrate equivalent skills that are sufficient to meet the demands of the Programme the applicant intends to pursue, and be approved as such by the Head of School or nominee.
- 1.3** This General Entrance Requirement is supplemented by the following additional provisions:

University English Language Policy;
University Welsh Language Policy;
Cardiff University's Admissions Framework.
- 1.4** Additionally, the admission of students at the point of entry may be subject to constraints imposed by health and safety legislation and professional, statutory and regulatory bodies' (PSRBs) requirements for specified programmes offered by the University.

- 1.5** Offers of admission made on the basis of applications containing false or misleading information may be revoked by the Vice-Chancellor (or his/her delegate) in consultation with the appropriate Head(s) of School. The applicant will be informed of their right of appeal via the Applicant Complaints and Appeals Procedure.
- 1.6** Allegations of applications containing false or misleading information made after the enrolment of an applicant shall be dealt with under the terms of the Student Behaviour Procedure.

Mae'r Brifysgol yn dymuno rhoi mynediad teg a chyfartal i bawb sydd â'r potensial i elwa ar amgylchedd dysgu ac addysgu'r Brifysgol, a arweinir gan ymchwil.

- 1.1 Rhaid i geiswyr ar gyfer Rhaglenni a addysgir neu raglenni ymchwil:
- 1.1.1 bodloni unrhyw ofynion gallu ieithyddol cymwys y Brifysgol, fel a ddisgrifir ym Mholisi Saesneg y Brifysgol a/neu Cynllun Iaith Gymraeg y Brifysgol.
- 1.1.2 bodloni unrhyw ofynion mynediad ychwanegol a bennir ar gyfer Rhaglen a addysgir neu raglen ymchwil benodol;
- 1.2 Rhaid i geiswyr ar gyfer Rhaglenni ôl-raddedig a addysgir neu raglenni ymchwil ôl-raddedig, yn ogystal â bodloni'r safonau gofynnol a bennir ym mharagraff 1.1 uchod, feddu ar:
 - 1.2.1 cymhwyster addysg uwch yn y DU ar lefel credyd 6 yr CQFW (Fframwaith Credydau a Chymwysterau Cymru) neu well gan sefydliad yn y DU sydd â'r pwerau perthnasol i ddyfarnu graddau fel y cydnabuwyd gan lywodraeth y DU ac y manylwyd arnynt ar ei wefan yn:

 - 1.2.2 cymhwyster na chafwyd mohono o'r DU ond sy'n cyfateb i lefel credyd 6 CQFW neu well² **neu**
 - 1.2.3 ar gyfer Rhaglenni ôl-raddedig a addysgir yn unig,
 - i gallu dangos, gan fodloni Pennaeth yr Ysgol neu ei (h)enwebai, eu bod wedi dal, am ddwy flynedd o leiaf, swydd gyfrifol sy'n berthnasol i'r Rhaglen y bwriadant ei dilyn; **neu**
 - ii o dan amgylchiadau eithriadol, os bernir eu bod yn gallu dangos sgiliau cyfatebol sy'n ddigonol i ateb gofynion y Rhaglen y bwriadar ceisydd ei dilyn, a chael eu cymeradwyo fel y cyfryw gan Bennaeth yr Ysgol neu ei (h)enwebai.
- 1.3 Caiff y Gofyniad Mynediad Cyffredinol hwn ei ategu gan y darpariaethau ychwanegol canlynol:

Polisi Saesneg y Brifysgol;
Cynllun Iaith Gymraeg y Brifysgol
Fframwaith Derbyn Prifysgol Caerdydd.
- 1.4 At hynny, bydd derbyn myfyrwyr yn atebol i'r cyfyngiadau a roddir arnom gan ddeddfwriaeth iechyd a diogelwch a gofynion cyrff proffesiynol, statudol a rheoleiddiol (PSRB), ar gyfer rhaglenni penodedig a gynigir gan y Brifysgol.

Rhoddir gwybod i'r ymgeisydd am ei hawl i apelio drwy gyfrwng Gweithdrefn Cwynion ac Apelau Ymgeiswyr.
- 1.6** Eir i'r afael â honiadau a wneir ar ôl cofrestru o geisiadau sy'n cynnwys gwybodaeth ffug neu gamarweiniol yn unol â thelerau'r Weithdrefn Ymddygiad Myfyrwyr.
