1. Programme Structure

This is a very well designed programme, the changes that have been introduced in the last few years are now well embedded.

2. Academic Standards

Academic standards are excellent. The students demonstrate excellent understanding of research methods and are certainly achieving comparable standards, if not higher, compared to other institutions.

3. The Assessment Process

This is very clear and in particular the processes for second marking are clearer and transparent.

4. Year-on-Year Comments

This is my final report and as in previous year I am impressed by the dedication of staff and the standards achieved by the students. There remains a tension between the emphasis on methods rather than more substantive topics and I would recommend that this division is kept under continual review, including students' own views on the balance of the course.

The MSc enables students to develop their expertise in qualitative and quantitative method, it gives students the skills to carry out research using a diverse range of methods. SAMPLING OF TAUGHT MASTER'S DISSERTATIONS BY EXTERNAL EXAMINERS

External Examiners shall be expected to see prescribed numbers and ranges of Dissertations, but not to mark them, on the following basis:

At least 10% of Dissertations for a postgraduate taught Master's Programme, or a minimum of 10 (whichever is the higher figure) must be seen by the External Examiner(s). Where the total number is less than 10, all Dissertations must be seen by the External Examiner(s) #.

Dissertations seen by External Examiners should include examples from across the whole range of achievement (i.e. Pass with Distinction, Pass, Fail).

External Examiners will retain the right to see other Dissertations at random.

Where more than one External Examiner is appointed on a Programme, at least 10% of Dissertations, or a minimum of 10 (whichever is the higher figure), should be seen collectively by the External Examiners.
