1. Programme Structure

Two year post-graduate qualifying social work degree programme, meeting requirements set by Care Council for Wales. Practice partners and service users and carers are appropriately involved within the programme. While there is overlap in subject content and structure with programmes in England (and to some degree Scotland) with which I am familiar, programme material reflects the distinctly Welsh practice and policy context. Increasing divergence in the Welsh policy context will see this distinctness increase in future years. The programme integrates a Masters qualification through completion of a research dissertation and is a generic programme offering education in both adult and children’s services practice, albeit students choose an area of preference in their second year, which is then linked to their third and final practice learning experience. The balance between genericism and specialism on the course is well managed and student feedback on this is positive.

2. Academic Standards

The standards expected of students and achieved by them in their academic work compare well with other post-graduate programmes with which I am familiar. The course has a strong and welcome emphasis on developing students as both critical thinkers as well as social work practitioners. Standards of written work expected from students are rigorous. The strongest student work I have seen is of a very high standard.

3. The Assessment Process

There is a good range of assessment tasks which are well thought through and link well to the particular learning outcomes in given modules. Of particular note is the consistent way in which thought has been given to trying to make links between academic assessment of student learning and practice learning through assessment tasks. The input and importance of practice agencies and practice educators within the assessment of student learning is very evident and visible. Currently, service user and carer involvement in the assessment process is less evident. This can be a challenging ask of social work courses and such involvement has to be meaningful for all concerned. However, it could be a future area of consideration for course development.

Academic feedback is detailed, helpful and clear. I have made a small number of suggestions about how this feedback might be further improved still in future.

5. Preparation / Induction Activity (for new External Examiners only)

- ❖ Overall standards of student work are high.
- ❖ A focus on developing social work students as critical thinkers as well as social work practitioners.
- ❖ Research dissertations show students' ability to undertake empirical studies and produce meaningful and important findings. There is a strong research culture within the Department and Masters of social work students appear well integrated into this culture.
- ❖ The course team is very open to discussion and suggestions as to ways in which the course might be further improved.
- ❖ The administrative support for the course (and External Examiners within this) is first class.
