No changes have been communicated to me, but the course appears to continue to reflect industry needs both in terms of the evergreen basics and the demand for new skills.

Appear to be consistently high. Commendably high pass mark on reporting exam.

The marking I saw was fair, transparent and accompanied by detailed annotations. The staff have picked up on the errors and oversights that I'd want them to highlight. The marking guide for the sports journalism module was particularly detailed. It is reassuring to know that the wide variation in the percentages of distinctions being given on different courses is being looked at.

4. Year-on-Year Comments

The markers' comments are now less anachronistic.

One minor thing to consider is perhaps the length of some of the patch stories – significantly longer than the average regional news website piece.

SAMPLING OF TAUGHT MASTER'S DISSERTATIONS BY EXTERNAL EXAMINERS

External Examiners shall be expected to see prescribed numbers and ranges of Dissertations, but not to mark them, on the following basis:

At least 10% of Dissertations for a postgraduate taught Master's Programme, or a minimum of 10 (whichever is the higher figure) must be seen by the External Examiner(s). Where the total number is less than 10, all Dissertations must be seen by the External Examiner(s) #.

Dissertations seen by External Examiners should include examples from across the whole range of achievement (i.e. Pass with Distinction, Pass, Fail).

External Examiners will retain the right to see other Dissertations at random.

Where more than one External Examiner is appointed on a Programme, at least 10% of Dissertations, or a minimum of 10 (whichever is the higher figure), should be seen collectively by the External Examiners.
