Comprehensive curriculum supported by excellent lectures, clinical sessions, including Genito-Urinary medicine (GUM), practical skills modules, workshops and video conferencing during surgical sessions. A cultural and communication skills induction to help students from abroad to understand how to work and interact with patients and staff in the UK health system.

Good academic standards with emphasis on evidence based practice, review of literature and research ethics.

There are a wide range of assessment methods covering the different modules of the course

The course is supported very well throughout with timely assessments- online MCQs/EMQs, pathology slides as well as clinical assessments. There was a good mix of clinical case discussions with emphasis on evidence base, immunology and pathogenesis of common (and not so common) skin diseases. Well thought out stations for clinical assessments with emphasis on clinical reasoning. To consider standardising the stations and covering aspects on professionalism and communication skills.
