1. Programme Structure (curriculum design, programme structure and level, methods of teaching and learning)

Oral Ecosystems is one of three themes in year 2 of the BDS curriculum (the others are Foundation and Clinical Dentistry), and collectively contribute to the Primary BDS Part 2 examination. The written examination for Oral Ecosystems requires two essays and four MSA questions to be attempted and accounts for 63% of DE2001(Primary BDS Part 2A).

The programme structure and content are very good, with a wide range of summative assessment methods being utilised (essays, MSA, practical, coursework). This ensures that a wide depth and breadth of knowledge is assessed.

Students are exposed to a wide range of highly suitable teaching and learning methods.

2. Academic Standards (comparability with other UK HEIs, achievement of students, any PSRB requirements)

I assessed the first diet of examinations on 3rd July 2017, specifically the written examination for Oral Ecosystems that comprised essays and MSA questions, and attended the Board of Examiners meeting that day.

Overall, a higher number of students (15) failed the Oral Ecosystems theme than in previous years, compared to only two failing Clinical Dentistry (13 students failed both themes). The vast majority of students who failed the Oral Ecosystems theme performed particularly weakly in the essays that were set as part of the written examination. Clearly, writing essays is challenging for some students, despite previously being provided with ample guidelines and marking criteria by staff for the extended essay that forms part of the coursework. Despite this, I approve of the use of essays as part of the assessment procedure since they allow students to demonstrate critical thinking and test in-depth knowledge and understanding of specific subject areas.

I am aware of the fact that this is the first year that standard setting of exam questions was introduced in response to comments last year by the other external examiner – this may also have contributed to lower attainment than in previous years, but to a lesser extent than the reasons described above for essay writing.

Student achievement is high and compares favourably with those of similar programmes elsewhere in the UK.

The programme aims and learning outcomes are highly appropriate and were successfully achieved by the assessment methods used. Assessment procedures are robust and high-quality examination questions were used. I was pleased with the range, depth and appropriateness of the assessment methods used.
