### 1. Programme Structure

The master's programme is organised so that RIBA part 1 and 2 can be completed over 5 years rather than 6 years which is typical in the UK. This is achieved through part of the first-year course work being undertaken in parallel with a minimum 9 months in practice.

The current internal review to refine the structure of the course to find the best balance between design teaching and learning in practice has been developed over the last year. The external examiners were presented with an update, including current plans for implementation in 2018. It appears that the review has the opportunity to further improve the course, and its reputation for high quality design grounded in practice.

The strong diversity of studios was complemented, and the possibility of collaborations between tutors and studios was discussed and encouraged.

The academic standards are high.

### 3. The Assessment Process

The assessment process is very thorough, based on a school structure of grade descriptions.

Initial marking is carried out by panels of 4 chaired by external assessors, followed by moderation attended by the external examiners.

The review of course structure has progressed significantly, with planned implementation in 2018.

The school is taking measures to increase studio space available for students, and thereby enhance studio culture in school.

#### **SAMPLING OF TAUGHT MASTER'S DISSERTATIONS BY EXTERNAL EXAMINERS**

External Examiners shall be expected to see prescribed numbers and ranges of Dissertations, but not to mark them, on the following basis:

At least 10% of Dissertations for a postgraduate taught Master's Programme, or a minimum of 10 (whichever is the higher figure) must be seen by the External Examiner(s). Where the total number is less than 10, all Dissertations must be seen by the External Examiner(s) #.

Dissertations seen by External Examiners should include examples from across the whole range of achievement (i.e. Pass with Distinction, Pass, Fail).

External Examiners will retain the right to see other Dissertations at random.

# Where more than one External Examiner is appointed on a Programme, at least 10% of Dissertations, or a minimum of 10 (whichever is the higher figure), should be seen collectively by the External Examiners.
