1. Programme Structure

The programme structure of the D.Clin.Psy is appropriate and in keeping with the HCPC requirements to prepare trainee clinical psychologists/ clinical psychology doctoral students to work as a professional clinical psychologists within the NHS.

2. Academic Standards

The academic standards of the D.Clin.Psy are very high. In all the work I examined I was impressed by the overall standard of the work, where students/ trainees demonstrated a good standard of theoretical and clinical knowledge. Across the research work, I noticed a significant improvement in the execution of the systemic reviews within the doctoral theses and the majority of the theses were written to a very high standard.

3. The Assessment Process

Overall, the assessment process by the internal examiners is very thorough and is in keeping with other clinical psychology doctoral programmes around the UK and Ireland. I was impressed by the examiner's thoroughness in their marking and the actual systems of ensuring academic and clinical standards within the written work.

4. Year-on-Year Comments

As I discussed above, the overall standard of work within the clinical psychology doctorates was high and this has continued within my second year as an external

examiner. Within the thesis, each student has to produce a systematic review and there were problems with these reviews in the last academic year. However, there was a noticeable improvement in these reviews within this academic year.

SAMPLING OF TAUGHT MASTER'S DISSERTATIONS BY EXTERNAL EXAMINERS

External Examiners shall be expected to see prescribed numbers and ranges of Dissertations, but not to mark them, on the following basis:

At least 10% of Dissertations for a postgraduate taught Master's Programme, or a minimum of 10 (whichever is the higher figure) must be seen by the External Examiner(s). Where the total number is less than 10, all Dissertations must be seen by the External Examiner(s) #.

Dissertations seen by External Examiners should include examples from across the whole range of achievement (i.e. Pass with Distinction, Pass, Fail).

External Examiners will retain the right to see other Dissertations at random.

- # Where more than one External Examiner is appointed on a Programme, at least 10% of Dissertations, or a minimum of 10 (whichever is the higher figure), should be seen collectively by the External Examiners.
