All modules are appropriate for Masters level study. There is a variety of teaching, learning and assessment methods which encompass different learning styles. The programme is structured logically and there is clear constructive alignment of all modules.

The standard of students work was good across the modules and was proportionate to Masters level study in other UK HEI's. There are some students whose work is exceptional and could be considered for publication.

3. The Assessment Process (enabling achievement of aims and learning outcomes; stretch of assessment; comparability of standards between modules of the same level)

All assessments are appropriate and allow for comprehensive coverage of the learning outcomes. The assessments are reasonable and provide students with opportunity to achieve a pass mark. There is evidence of appropriate support and documentation available in order to assist students to undertake the assessments. Marking is consistent and there is clear and detailed feedback and Feedforward provided. There is evidence of robust internal moderation.

A sufficient sample of MSc Dissertations was received, aligning to University sampling guidelines. Dissertations were of a very good standard, evident of very good supervision and teaching. Internal marking was consistent with good use of intext comments as well as overall feedback and Feedforward. Marking was consistent with classification of awards. There are some dissertations which were completed to a very high standard and could be considered for publication.

Staff at Cardiff continue to be very responsive to External Examiner feedback and aim at all times to deliver a professional and quality service.

There has been excellent supporting information provided by the programme team in the form of face to face discussions, online meetings and online videos. All materials are emailed for review with clear instructions on how to access and feedback requested.

The Blog and Wiki assessments are innovative methods of assessment which are in keeping with the developments in technological advances. These assessments permit students to add links and diagrams to enhance their work. There is evidence of excellent support for students to complete these.
