The programme continues to set the benchmark for journalism courses across the UK. The structure is comprehensive, well-thought out, up-to-date and academically rigorous. It provides both a sound academic course and a good preparation for students in the workplace.

The standards are first class. The quality of the best work is truly excellent and the course clearly attracts and enhances some of the brightest students in the country.

### 3. The Assessment Process

The assessments were clear and the marking was rigorous, consistent and transparent. The grade classifications were appropriate and consistently applied to the entire sample that I saw, which was very substantial.

### 4. Year-on-Year Comments

The course continues to provide a first-rate journalism education and I was very encouraged to see standards maintained at such a very high level. We discussed a higher than normal number of fails in law and, having reviewed the papers in some detail myself, concur with the lecturer's conclusion that there was no 'one cause' for these fails, but a variety of factors and an unusual 'blip' in what is an excellent course.
