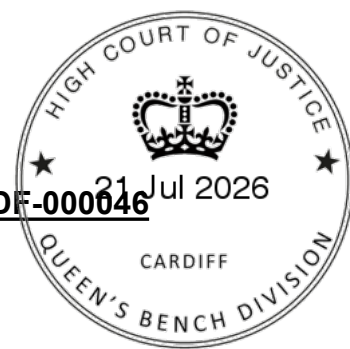

ORDER

UPON the Claimant's possession claim by Claim Form, dated 27 May 2025, and its application for an injunction, dated 27 May 2025 ("**the Application**").

AND UPON the Order of Sir Peter Lane dated 13 June 2025 ("**the Order**") which granted the injunction that until 23:00pm on 31 July 2026, the Second Defendants must not without consent (a) enter, occupy or remain upon the Land for the purposes of protest (b) directly block, obstruct or interfere with the access of any individual to the Land with the intention of stopping that individual accessing the Land (c) erect or place any structure (including, for example, tents, gazebos or other sleeping equipment) on the Land ("**the Injunction**").

AND UPON the Injunction being listed for a Review Hearing in accordance with paragraph 12 of the Order.

AND UPON hearing Counsel for the Claimant and there being no appearance by or on behalf the Defendants.

AND UPON there being no appearance by or on behalf of the Intervener.

AND UPON the Court reading the Witness Statement of Professor Wendy Larner and Exhibit WL1 dated 6 July 2026.

AND UPON the Claimant acknowledging that it has an ongoing duty to bring to the Court's attention any material change in circumstances which may affect the continuation or the terms of this Order.

AND UPON the following terms having the following meanings in this Order:

"the Land" being all or any part of the land referred to in the Particulars of Claim in respect of which the University seeks precautionary injunctive relief as shown for identification purposes edged blue on the attached plan at Schedule 1 marked '**Plan 2**', being the land and buildings known as and situate at:

- (a) Main Building, Park Place, Cardiff CF10 3A, including the area of green space located at the rear of Main Building known as "Horseshoe Drive";
- (b) Glamorgan Building, King Edward VII Avenue, Cardiff CF10 3WT;
- (c) Bute Building, King Edward VII Avenue, Cardiff, CF10 3NB;
- (d) Centre for Student Life, Park Place Cathays Cardiff CF10 3BB;
- (e) Sir Martin Evans Building, Tower Building and Law Building, Cardiff, CF10 3AX;
- (f) 50-51 Park Place, Cardiff, CF10 3LU/CF10 3AT;
- (g) The external area in front of the Music Building, 31 Corbett Road, Cathays, CF10 3EB;
- (h) Abacws, Senghennydd Road, Cardiff, CF24 4AG;
- (i) Trevithick Building, Newport Road, Cardiff, CF24 3AA;
- (j) Queen's Buildings, 5 The Parade, Newport Road, Cardiff, CF24 3AA; and
- (k) Spark, Maindy Road, Cardiff CF24 4HQ.

IT IS ORDERED THAT:-

POSSESSION

1. The claim for possession remains adjourned generally with liberty to restore.

INJUNCTION

2. In accordance with paragraph 2 of the Order, the Injunction will terminate on 23:00 on 31 July 2026.

UNDERTAKING

3. The Claimant's undertaking given at Schedule 2 of the Order is discharged at 23:00 on 31 July 2026.

4. This Order shall be notified to Persons Unknown by the Claimant carrying out each of the following steps:
