



### STEP 1

You'll receive an automatic acknowledgement of your application when submitted and be granted access to the online applicant portal, where you can track your application, upload any additional supporting documents and update your contact details.

### YOUR OFFER:

You can track the progress of your application in our online applicant portal. You'll also receive an email containing the details of your offer. Most applicants will receive an offer within four weeks, although some may take longer. Your offer could be:

**Conditional:** You need to submit additional evidence. In most cases this will mean providing copies of your qualification certificates when they become available.

**Unconditional:** You've been offered a place – congratulations!

**UK/EU students:** In most cases, all you'll need to do to secure it is to accept your offer.

**International students:** You'll need to accept your offer and pay a deposit to secure your place.
